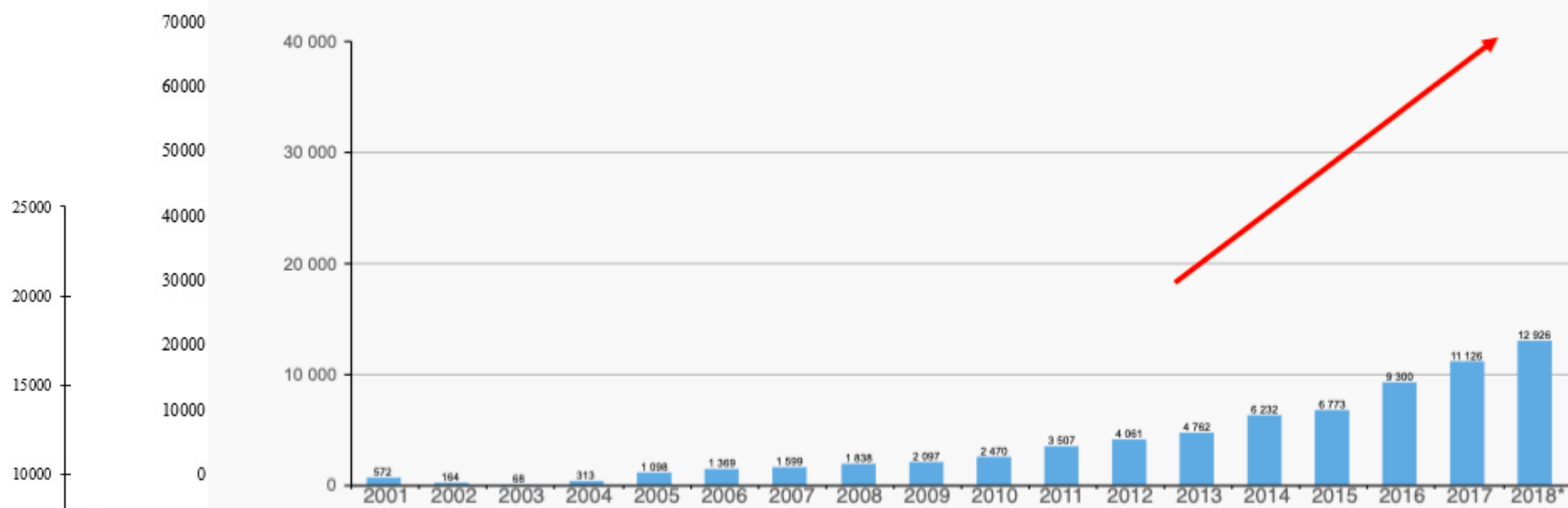

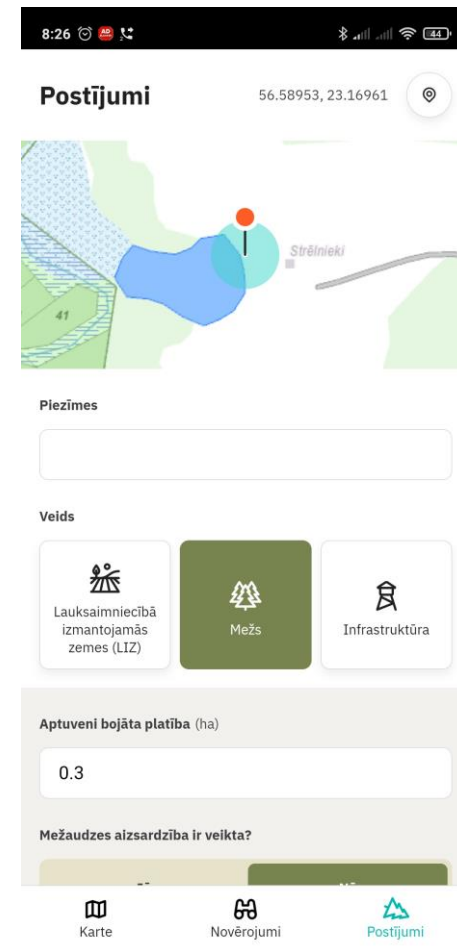
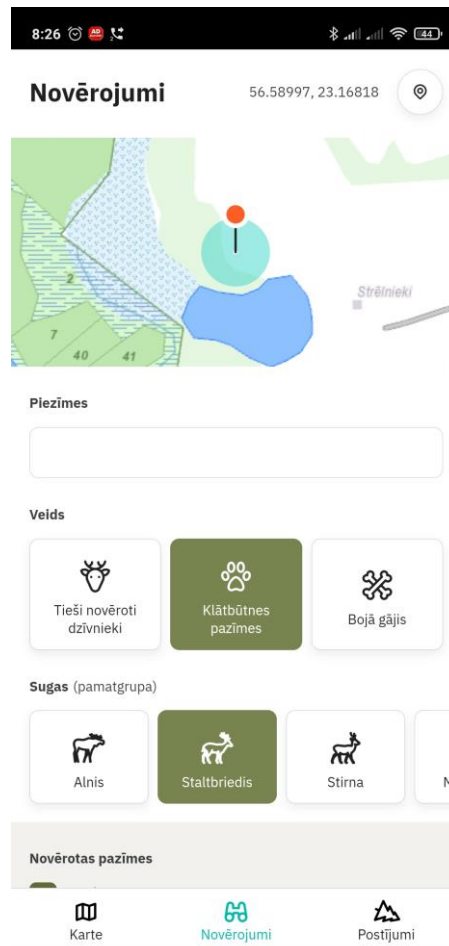
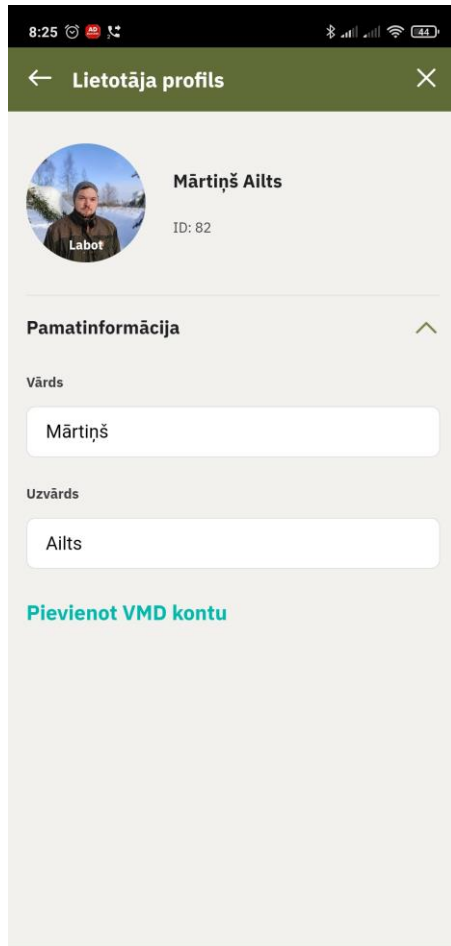
# Changes of regulations
